**Motion** by Anthony Long and seconded by Cedric Hudson to accept the total annual increase of county health insurance of \$6,720 (to be absorbed by the employer). **Motion carried.**

**Motion** by Anthony Long and seconded by Thomas Harrison to grant an industrial access road to Old Plasma Cutting located on Hwy 5. **Motion carried.**

**Motion** by Thomas Harrison and seconded by Anthony Long to accept DHR board recommendations and reappoint Julia Cash, Frances Ford and Malyssa Chandler to full terms. **Motion carried.**

**Motion** by Anthony Long and seconded by Cedric Hudson to appoint Roberta Adams to fill the unexpired term of deceased member Alfred Adams. **Motion carried.**

**Motion** by Benjamin Eaton and seconded by Cedric Hudson to require all individuals who enter the courthouse to wear a mask effectively immediately until March 1, 2022; **Substitute motion** by Thomas Harrison and seconded by Anthony Long to recommend mask wearing for all individuals entering into the courthouse and a mandatory temperature check. *Roll call vote requested:* District 1: Abstain; District 2: Nea; District 3: Nea; District 4: Nea; District 5: Nea. **Substitute motion was not carried. Roll call vote requested for original motion: District 1: Yea; District 2: Nea; District 3: Nea; District 4: Yea; District 5: Yea. Original motion carried.**

**Motion** by Cedric Hudson and seconded by Benjamin Eaton to require wearing a mask when interacting directly with customers and not behind protective glass. *Roll call vote requested:* District 5: Yea; District 4: Yea; District 3: Nea; District 2: Nea; District 1: Abstained. **Motion was not carried.**

**Motion** by Albert Turner (gavel passed to Vice Chairman Harrison) to require all employees to wear a mask upon entering the courthouse and county buildings and shall also wear a mask during work hours effective immediately until March 1, 2022. **Motion died for lack of a second.**
